**SERVICE ORDER NO. 74 / 2010**

**SUB : 27<sup>th</sup> INTER ZONAL TRANSFERS-2010 – ASI/FIRE**

The personnel listed in Appendix "A" to this letter are posted to the Sectors/Zones as shown against each with immediate effect.

2. All the affected personnel should be relieved by 30.04.2010 without waiting for their substitutes with direction to report to their new places of posting after availing their eligible joining time. Those who want to move earlier due to any reason can move accordingly. In case, any of the personnel are under order of posting/relieved on regular posting within the zone, their cases should be brought to the notice of this Directorate for further necessary action.

3. Requests of all personnel whose names were forwarded by the respective IsG/DIsG including all those cases which were decided to review in IZT-10 have been duly examined and necessary action taken wherever possible on merit. However, all personnel could not be adjusted for want of vacancies in the desired places. **Remaining cases, if any, may be treated as "Rejected" repeat – "Rejected"** as having no merits. This may be brought to the notice of the Unit personnel. The resultant vacancies if any arising out of these posting orders will be filled up in due course.

4. Representation, if any, only on extreme/exceptional cases and all other correspondence in this regard should be routed through the respective Zonal/Plant DIsG/Sector IsG quoting the serial number of the posting order clearly in accordance with the instructions contained in this Directorate letter No.E-38011/1/95/Estt-I/188 dated 28/02/1995 so as to reach this Directorate within 15 days from the date of receipt of this letter, failing which, no action will be taken for such belated representations. Representations without mentioning the serial number and other details of the transferees and not routed through respective Sector IsG will not be entertained and no action will be taken for such correspondence on this subject. In this connection, attention is also drawn to this Directorate letter No.E-38011/1/91/Estt.II dated 28/02/1991. All the Zonal/Plant DIsG/Sector IsG are requested to instruct their Unit Commanders that they should not make any correspondence direct to this Directorate in this regard. Deviation, if any, of these instructions will be viewed seriously. Further, it may be ensured that a case when once decided by this HQrs should not be taken up again.

5. The salaries in respect of affected personnel will not be claimed by the present DDOs after 30/04/2010 (AN) failing which the DDOs will be personally held responsible for the lapse. Their movement orders/LPCs paid upto 30/04/2010 (AN) should be sent to their new DDOs without fail. In case, any of these personnel are facing departmental enquiry, their proceedings should be completed within the stipulated time and they should be relieved forthwith simultaneously moves may be made to avoid surplus/deficiency, if any.

6. In case of duplication of posting, they may be relieved to the Unit, which is favourable to them. Subsequently, this may be brought to the notice of this Directorate for issue of cancellation orders.

7. All Zonal/Plant DIsG are requested to forward the particulars of the personnel affected from their Zones to the IsG of the concerned Sectors to which personnel are earmarked for posting to facilitate the concerned IsG to allot appropriate Units to the personnel mentioned in Appendix 'A' in their respective Sectors and also to avoid reposting in the same Unit. The personnel who have not done hard area posting may be earmarked to have tenure in the hard units so as to rotate the personnel who are already posted in the hard units and completed their tenure. All Zonal/Plant DIsG are requested to **submit a consolidated compliance report to reach this Directorate by 05/05/2010 in the proforma circulated vide this Directorate letter No.E-39011/1/92/Estt.II dated 23/11/1992 mentioning the names of personnel if any not to be relieved with reasons thereof, for information of DG/CISF.** In this connection instructions issued vide this Directorate letter No.E-26099/1/18/92/Estt.II dated 02/03/1993 may be referred to.
