2. Before promoting them, it should be ensured that they fulfill the following conditions:-

- They are confirmed in the entry grade or in the present rank.
- They have successfully completed the promotion cadre course of SI/Min.
- They have been declared in the medical category SHAPE-I before being declared fit for promotion by the DPC. If there is any deterioration in the medical categorization after the DPC and before actual promotion, the promotion will be withheld.
- No disciplinary/legal proceedings are either pending or contemplated against them and promotion should not be given during currency of punishment.
- In the case of SC/ST candidates, it may be ensured that a certificate to the category issued by competent authority is available in their service documents. After verifying the same, the concerned individual be promoted/relieved on promotion-cum posting to the concerned unit.

In case any of them is unwilling to move on promotion due to his own volition, a certificate to this effect (duly countersigned by the authority concerned) indicating that he is willing to forgo his promotion and will not claim for seniority be obtained from him and forward to this Directorate (Estt.I Branch) in duplicate latest by 25.01.2010.

4. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of SI/Min. In the promotion order it may be mentioned that Govt. Servant has to exercise the Option within one month for fixation of his pay under FR-22.

5. Sector IsG are requested to allot them units on promotion to the rank of SI/Min.
