SERVICE ORDER PART-I NO. 301 /2009

Subject: - PROMOTION-CUM-POSTING TO THE RANK OF ASI/EXE.

No.764470088 HC/GD Ram Nishan Singh Yadav (PSL No.12663) of CISF unit IPGI Airport New Delhi who has been found "FIT" by the DPC held in the year 2009 is promoted to the rank of Asstt Sub Inspector (Exe) on regular basis. He is posted to APS on promotion. The promotion will take effect from the date he assumes charge as ASI/Exe in new place of posting.

2. Before promoting them, it should be ensured that he fulfills the following conditions: -
 - a) He is confirmed in the entry grade or in the present rank.
 - b) He has successfully completed the promotion cadre course of ASI/Exe.
 - c) He has been declared in the medical category SHAPE-I before being declared fit for promotion by the DPC. If he is any deterioration in the medical categorization of empanelled HCs after the DPC and before actual promotion, the promotion will be withheld.
 - d) No disciplinary case is pending against them and promotion should not be given during currency of punishment.
 - e) In the case of SC/ST candidates, it may be ensured that a certificate to the category issued by competent authority is available in their service documents. After verifying the same, the concerned individual be promoted/relieved on promotion-cum posting to the concerned unit.
3. In case any of the individual is unwilling to move on promotion due to his own volition, a certificate to this effect duly countersigned by the authority concerned indicating that he is willing to forgo his promotion and will not claim for seniority be obtained from him and forwarded to this Directorate (Estt.I Branch) in duplicate latest by 10.12.09.
4. The promotion is without prejudice to the claim of other HCs whose formal order for promotion to the rank of Asstt. Sub-Inspector/Exe is being issued separately. Their inter-seniority will be in order of panel drawn by the DPCs.
5. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of ASI/Exe in the new unit. In the promotion order it may be mentioned that Govt. Servant has to exercise the Option within one month for fixation of his pay under FR-22.

6. ADG/APS is requested to allot him units on promotion to the rank of ASST Exe.
