Subject: - **PROMOTION –CUM-POSTING TO THE RANK OF INSP/MIN.**

The following SI(Min/Accts) who have been found fit by the DPC held in the year 2009 are promoted to the rank of Inspector (Min) on regular basis. They are posted to the Sectors/Zones as shown against their names against existing vacancies. Their promotion will take effect from the date they assume charge as Insp/Min in the new place of posting: -

2. Before promoting them, it should be ensured that they fulfill the following conditions:

- a) They are confirmed in the entry grade or in the present rank.
- b) They have successfully completed the promotion cadre course of Insp/Min.
- c) They have been declared in the medical category SHAPE-I before being declared fit for promotion by the DPC. If there is any deterioration in the medical categorization of an empanelled SI/Min after the DPC and before his actual promotion, the promotion will be withheld.
- d) No disciplinary/legal proceedings are contemplated / pending against them
- e) Promotion should also not be given during the currency of punishment, if any.

- f) In the case of SC/ST candidates, a certificate to this effect from the competent authority is available in their service documents.
3. They will be on probation for a period of 2 years from the date of assumption of charge of the post of Inspector (Min) and the said promotion will be subject to satisfactory completion of period of probation.
4. In case any of the individual is unwilling to move on promotion due to his personal reasons, a certificate to this effect indicating that he is willing to forgo his promotion at his own volition and will not claim promotion and seniority later on be obtained in writing from him and forwarded to this HQrs (Estt.I Branch) in duplicate latest by 31.12.2009.
5. Sector IsG are requested to allot unit on promotion to the rank of Inspector (Min). The DG CISF while approving the panel has endorsed the remarks that “*While posting these officers, they should not be posted to same unit*”.
6. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Inspector (Min) in the new unit. In the promotion order it may be mentioned that Govt. servant has to exercise the option within one month for fixation of his pay under FR-22.
7. Compliance report along with charge assumption report will be forwarded to Estt.I Branch and R&S Branch of this HQrs latest by 31.12.09.
