Subject:- **PROMOTION-CUM-POSTING TO THE RANK OF INSP/STENO.**

The following SIs/Steno who are found fit by the DPC held in the year 2009 are promoted to the rank of Inspector/Steno on regular basis. They are posted to the Sectors as shown against their names against existing vacancies. Their promotion will take effect from the date they assume charge as Inspector/Steno in the new place of posting.

2. Before promoting them, it should be ensured that they fulfill the following conditions: -

- a) They are confirmed in the entry grade or in the present rank.
- b) They have successfully completed the promotion cadre course of Inspector/Steno.
- c) They have been declared in the medical category SHAPE-I before being declared fit for promotion by the DPC. If there is any deterioration in the medical categorization of an empanelled SI/Steno after the DPC and before his actual promotion, the promotion will be withheld.
- d) No disciplinary case/vigilance/legal proceeding is pending/contemplated against them and promotion should not be given during currency of punishment.
- e) In the case of SC/ST candidates, it may be ensured that a certificate to the category issued by competent authority is available in their service documents. After verifying the same, the concerned individual be promoted/relieved on promotion-cum posting to the concerned unit.

3. In case any of the individual is unwilling to move on promotion due to his own volition, a certificate to this effect (duly countersigned by the authority concerned) indicating that he is willing to forgo his promotion and will not claim for seniority be obtained from him and forwarded to this Directorate (Estt.I Branch) in duplicate latest by 05-01-2010.

4. On promotion they will be on probation for a period of two years in the rank of Insp/Steno from the date of assumption of charge and their promotion will be subject to satisfactory completion of the said period of probation.

5. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Inspector/Steno in the new unit. In the promotion order it may be mentioned that Govt. Servant has to exercise the Option within one month for fixation of his pay under FR-22.
