**SERVICE ORDER PART-I NO. 320 /2009**

**Subject:- PROMOTION-CUM-POSTING TO THE RANK OF INSP/EXE.**

The SIs/Exe mentioned in Appendix-A are found fit by the DPC held during the year 2009. They are promoted to the rank of Inspector (Exe) on regular basis and posted to the Sectors as shown against their names against existing vacancies. Their promotion will take effect from the date(s) they assume charge as Insp/Exe in the new place of posting.

2. Before promoting them, it should be ensured that they fulfill the following conditions: -

- a) They are confirmed in the entry grade or in the present rank.
- b) They have successfully completed the promotion cadre course of Insp/Exe.
- c) They have been declared in the medical category SHAPE-I before being declared fit for promotion by the DPCs. If there is any deterioration in the medical categorization of an empanelled SI/Exe after the DPC and before his/her actual promotion, the promotion will be withheld.
- d) No DE/Vigilance/disciplinary/legal proceedings are pending/Contemplated against them.
- e) Promotion should also not be given during the currency of punishment, if any.
- f) In the case of SC/ST candidates, a certificate to this effect from the competent authority is available in their service documents.

3. They will be on probation for a period of 2 years from the date of assumption of charge of the post of Insp(Exe) and the said promotion will be subject to satisfactory completion of said period of probation.

4. In case any of the individual is unwilling to move on promotion due to his personal reasons, a certificate to this effect (duly countersigned by the Head of Office) indicating that he is willing to forgo his promotion and will not claim promotion and seniority later on should be obtained from him and forwarded to this HQrs (Estt.I Branch) in duplicate latest by 08.01.2010.

5. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Insp/Exe in the new unit. In the promotion order it may be mentioned that Govt. Servant has to exercise the Option within one month for fixation of his pay under FR-22.
